### President's Letter - Dr. Peter Pellegrini

Happy spring, Snohomish County Colleagues! Queen Elsa has finally "let it go" and Washington's 2019 eternal winter has officially given way to spring...a time of renewal. Speaking of "renewal," in this month's president's message I would like to discuss continuing education— especially as it pertains to license renewal, as we have seen a lot of changes recently. This January, a number of CE changes went into effect, and I encourage you to review the latest CE requirements. (go to www.wsda.org and click on CE FAQ's)

The basics for dentists: 63 total hours are needed every 3 years. That means that you can do more in one year (or all, theoretically) in that 3 years. Ok, so let's also review opioid and jurisprudence CE, along with Basic Life Support (and how much BLS CE counts toward your cumulative tally). Opioid requirements: Given the 2019 change, dentists have 3 years (from their birthday license renewal date) to complete the one-time 3 hour CE requirement for opioid prescribing. Example: My birthday is January 7: I will have until January 7, 2022 to complete my CE. Those who attended our SCDS March 1st Seminar will have fulfilled the 3 hours towards this one-time opioid CE requirement. Jurisprudence CE exam: 1 hour needed every three years. This is a recent, less well-known CE update, and this open book "test" is available online.

 $\underline{\mathit{BLS}}$ : Health care provider BLS certification is required every 1 to 3 years, depending the course taken. The current CE rules still allow BLS to count for CE, but there is now a prohibition that only allows 1 hour to count for CE each year that BLS is taken. The dentist may only claim 1 credit per each time the BLS is taken so in a 3 year reporting period they can claim up to 2 credits if they have taken the course twice, assuming in this example that the dentist was certified for 2 years. First aid is not a licensing requirement, but first aid CE does count.

Hypothetical Example:

**2019**: The below CE taken in '19 would apply a total of 44 credits towards a dentist's 2022 birthday deadline for license renewal.

- Attend a 3 credit BLS course and a 3 credit first aid course. (4 total credits claimed)
   NOTE that only 1 of the BLS CE credits applied.
- Attend 6 SCDS meetings (12 credits)
- SCDS Annual Seminar: 7 credits claimed, 3 credits applied to the one-time opioid requirement.
- Other CE: 21 total credits claimed

**2020**: The below CE taken in '20 would apply a total of 21 credits towards a dentist's 2022 birthday deadline for license renewal.

- Jurisprudence online course 1 credit claimed
- Attend 5 SCDS meetings (10 credits)
- Other CE: 10 credits claimed

**2021:** The below CE taken in '21 would apply a total of 19 credits towards a dentist's 2022 birthday deadline for license renewal.

- Attend 4 SCDS meetings (8 credits)
- SCDS Annual Seminar: 7 credits claimed
- Attend a 3 credit BLS course. \*NOTE that only 1 of the BLS CE credits applied
- Other CE: 3 credits claimed

This example would have a total of 94 CE credits claimed for the 63 minimum, and demonstrates how only 2 of the two BLS courses' credits would apply. It also highlights how much CE one can obtain from SCDS resources, as each SCDS meeting provides 2 hours of CE. With that in mind, I will "CU" at the next meeting—our annual joint hygiene meeting on the topic of peri-implant disease, featuring Dr. Kevin Suzuki.
