# President's Letter By Dr. Peter Pellegrini



Greetings Snohomish County colleagues:

I am composing this letter having just returned from the WSDA House of Delegates meeting in Tacoma, so I will begin with a recap of the more pertinent proceedings. Elections for the various WSDA open positions were held and resolutions were voted upon. Below are some of the more applicable resolutions that were passed, which will lead to the addition of the following items to the legislative agenda:

- •HD-11-2018: Enabling providers to choose the method of reimbursement by insurers, which would *not* allow insurance companies to require electronic payments/virtual credit cards
- •HD-12-2018: Ensuring dental benefits (preventing denial of claims that have been preauthorized)
- •HD-13-2018: Creating a task force to look into the possibility of WSDA-endorsed professional liability options.
- •HD-14-2018: Improving dental insurance efficiencies, including direct reimbursement to in- and out-of-network providers, as well as elimination of non-duplication clauses.

Again, these will be part of the agenda, but that is the initial step towards positive change.

We discussed the status of WDS/Delta Dental activities. Since I am often asked about the progress on this front, I will review, much as we did at the HOD. Let's recap the last year's activities:

- •September, 2017: Almost a year ago, a special meeting took place during which over 91% of members voted for bylaws amendments.
- •October, 2017: WDS vetoed a lot of the bylaws amendment, also citing a 2013 "reorganization."
- October, 2017: WDS canceled the annual meeting
- •March, 2018: WDS CEO Dwyer departure was announced / WSDA issued a "no confidence" vote of Dwyer,
- •June, 2018-present:
  - -WSDA contacted OIC (Office of the Insurance Commissioner) with regard to investigation into illegal practices and to illegal monopsonistic activity
  - -WDS cancellation of annual second meeting (Delta's refusal to hold an annual meeting for a second year in a row denies member dentists participation rights)

That leads to the next step: Please be aware that a WDS special meeting will likely take place in October to mid-November, and once again, your **attendance is critical**. If attendance is not possible, please **assign proxy to an attending member**. Your presence is most important so that delta member dentists can have the opportunity to present and adopt new round of bylaws amendments.

I am a lover of words—a logophile—and one word that doesn't get tossed around too much in daily conversation is "monopsony." We all know the concept of a monopoly, and many of us like the board game of the same name. What is a monopsony? It is when a market structure (buyer) controls the market (controls a large proportion of the market) and drives prices down. Think of it as a "buyer's monopoly." complaints that the WSDA has with WDS. The WSDA has asked the WA Attorney General's Office to investigate whether WDS (Delta) has engaged in illegal monopsonistic practices in our state. For more updates, please go to the WSDA website at www.wsda.org. Know that your society and your state association are working incessantly to allow its member dentists to best deliver dental care in our state.

Speaking of changes, please be reminded that the Opioid Prescription rules are scheduled to take effect on Jan 1, 2019. This involves CE completion and guidelines and documentation that we will need implement. I will provide an update in my next newsletter, so stay tuned for more.

Are you having a difficult time finding qualified hygienists and assistants? Did you fill out the DOH Survey regarding the health professional shortage? We also discussed this workforce shortage issue and the feedback from the survey recently issued. Know that we are looking into solutions to the workforce shortage and the association is exploring legislative avenues to help with the shortage.

Since great, qualified employees are hard to find, a wonderful way to say thanks to those that are part of own offices is to celebrate them at the Annual Staff Appreciation Dinner. The SCDS Gala will be on Thursday, November 15<sup>th</sup> with Jet City Improv providing the entertainment. This should be a great night out and a great way to treat your team.
