PRESIDENT'S LETTER - By Dr. B. Ardi Pribadi

Hello everyone! If you're like me, you're ready to be done with 2020 and move onto 2021 already. This past year has been a year like no other. So many deaths, so much anger, and so divided. There were many opportunities for this pandemic to destroy dental offices and for those who are standing and thriving, congratulate yourselves, for it is your resilience and your sheer grit



and determination that your practice has overcome the fate that is happening to many businesses around the country.

I want to thank the ADA and WSDA for advocating on our behalf, for making the government realize that dentistry is essential, for including us in the HHS CARES ACT and for lobbying the government to keep dentistry open. Many are quick to point out what our association is lacking, but let's take a step back and understand exactly what they really did for us this year.

The vaccine is just around the corner. Some of you may have already received the Pfizer vaccine and/or know people who have received it. Moderna's vaccine has just been approved for emergency use and is in the process of distribution. The ADA is working very closely with the Federal Government to ensure that those in the dental field aren't overlooked, and the WSDA is working very hard with the WA Department of Health to create a viable rollout plan for dentists. Meanwhile, the Dental Quality Assurance Commission has also given their blessing to allow dentists and dental hygienists the ability to provide vaccinations as part of their scope of practice. I encourage you, who are interested, to reach out and volunteer as a service to your community.

Presently, the demand for the vaccine far outnumbers the supply available, but after a few weeks/months, the supply will catch up and demand will dwindle, but not the need to achieve herd immunity. It is crucially important that misinformation and lies from the anti-vaxxer community does not become widespread. Pseudoscience is the biggest detriment in achieving herd immunity and I implore each and every one of you highly educated dentists to dig deep into your science background and educate your staff (many who may only have a high school science background) and inform them what a vaccine is, how it works, how it benefits everyone and that it is completely safe and effective.

Together, if we do our part, the possibility of eradicating COVID-19 is very much a reality. Happy New Year and have a safe and wonderful holiday season!
